

■Regarding the map data

1. Regarding creation of map data included in this product (hereinafter “Map Data”), it was created by ZENRIN CO., LTD (“ZENRIN”) on the basis of the National Digital Road Map Database issued by the Japan Digital Road Map Association (JDAA), with approval of Geospatial Information Authority of Japan, (based on Article 44 of the Survey Act, use approval 12-0040).
2. For the creation of this Map data, ZENRIN with approval of Geospatial Information Authority of Japan use 1:500,000 regional maps and 1:25,000 topographic maps, issued by the same authority (based on Survey Act of Geospatial Information Authority (use) R 2JHs 293—B87).
 - Micro city map data is based on ZENRIN residential map database. However it can happen that some regions are not included into micro city map, due to the different creation timing and maintenance conditions of some regions.
 - The latitude and longitude coordinate values displayed in this product are based on the Japan Geodetic System. Depending on creation timing of base map, it can happen that map data for newly constructed roads may not be included, and some names and roads may differ.
3. This map data was created with the approval of Geospatial Information Authority of Japan, using its Technical Document H.1-No.3, “Correction for the position of isolated islands in Japan’s Geodetic System. (Approval No. National Land Survey No. 78, April 23, 2004)
4. For the creation of 3D map, it was created using numerical map 50m mesh (elevation) with the approval of Geospatial Information Authority of Japan and published by it (based on Survey Act of Geospatial Information Authority (use) R 2JHs 294—B87)..
5. Data on locations with a frequent traffic accidents (black spots) are created by ZENRIN based on map data provided by Japan Traffic Management Technology Association (non-profit foundation) and by Institute for Traffic Accident Research and Data Analysis (non-profit foundation) from November 1998.
6. The road data is produced based on the information collected until approximately year 2020 for expressways and toll roads, and until approximately year 2020 for national, prefectural, and major regional roads. However, it can happen that displayed map may differ from the current situation.
7. Currently, due to the effects of the earthquake in East Japan occurred on March 11, 2011 map updates were suspended in following regions with entering restriction:
Minamisōma (one part), Tamiemachi, Futabacho, Ookumacho, Tomiokacho, Narahamachi, Iidatemura, Katsuraomura
